**SCHEDULE:**

**SETUP:** 2 nets setup in the main high school gym. 5 minutes between matches.

**HOME TEAM AND BENCH:** The team listed first on the schedule is the home team and will serve first. The home will be the left bench when looking onto the court.

**LOCKER ROOMS:** Team locker rooms will be open but not specifically assigned. Officials will have their own room.

**GAME BALLS:** Warmup volleyballs and game balls will be provided. Volleyballs must remain in the gym at all times.

**CONCESSION:** Concession stand will be open and available. Tables for team food and setup will be in the cafeteria.

**CHAMPION:** Championship trophy awarded to the first-place team after the final match between the two pool winners.

**FORMAT:** Round robin matches will consist of best of three matches to 25 (3<sup>rd</sup> match to 15) with the win by two format.
